A Renewed Spirit of Collaboration!

After a two-year hiatus, once again there will be one newsletter serving all Indian Mountain property owners. The Indian Mountain Recreation and Park District (IMRPD) Board and the Indian Mountain Property Owners Association (IMPOA) Board both voted unanimously to combine money and energy to produce one high quality newsletter.

The decision was quite simple. One joint newsletter would,

- require only one volunteer editor
- reduce the combined number of newsletters from 7 to 3 per year
- save over \$3K in taxpayer's money



• help to rebuild a spirit of collaboration between two important organizations that serve Indian Mountain.

The IMRPD President's Report

It has been a very busy four months since the May IMRPD elections. Let me recap some of the highlights: There are five newly elected Board of Directors:

- Fred Burdick, President (4-year term)
- Susan Stoval, First Vice President (4-year term)
- Susan Bigham, Second Vice President (2-year term)
- Joe Bush, Treasurer (2-year term)
- Glenn Haas, Secretary (4-year term)

The IMRPD support group consists of:

- Midge Wheeler, Bookkeeper
- Louise Mark, Office Manager
- Dawn Gonzales, Facility Housekeeping
- Forrest Wheeler, Maintenance.

We have completed or started on several of our platform goals which include:

- Cooperate with Indian Mountain Property Owners Association (IMPOA) to produce a tri-annual newsletter. After carefully researching the issues, both groups decided to join efforts in publishing a single newsletter. Each organization will share equally in the costs and will report their own news items.
- To guide strategic planning a survey was sent to all property owners in the Indian Mountain subdivision. The results will be carefully reviewed and priorities developed based on findings.
- The District hosted a summer picnic at the Park at the IM Park facilities. Over 175 property owners and their families enjoying a day of food, fun and fellowship.

Recent facility improvements

- The interior of the Comfort Station has been painted, emergency lights installed and new commercial ventilation fans have replaced the smaller inadequate ones.
- Picnic tables have been repaired and three new ones have been ordered.
- The RV storage lot is getting a new face lift. IMRPD has disposed of 16 abandoned vehicles, cleaned up weeds, picked up trash, and filled gopher holes.
- The office building deck, playground equipment and fences have been stained and sealed.
- The information Kiosk now has lighting and power. A map showing where IMRPD facilities are located and providing district news and events will soon be posted.
- New security measures have been implemented for District files and documents.
- Two new fire proof file cabinets purchased to protect all IMRPD files from catastrophic loss.
- We have implemented a back-up system for the commuter with storage of records at an off-site location.
- All the Districts funds are fully insured against financial institution loss.
- The RV dump station has been pumped and the site re-groomed to make trailer access safer and easier.
- The IMRPD website has been revamped to provide a more user friendly format. Visit the new site at www.indianmountain.info for information, current events, and IMRPD facts.
- The District Board has implemented study sessions to incorporate public input and ideas. In addition, the board is conducting business meetings on Saturdays making it easier for the public to attend.

What does the future of IMRPD hold?

• Your new Directors are committed to maintaining, enhancing and improving the recreational and park amenities offered for the enjoyment of all Indian Mountain property owners, their families and friends. By developing a well reasoned 2009-2013 IMRPD Strategic Plan, we will lay out details on our priorities, allocations of money, and a sequence of actions for where your Board is going. Your input will be important and we promise to keep you informed.



What Should IMRPD Do for You?

One of the first and reoccurring questions asked of the new IMRPD Board this summer was *"What are you going to do---what is your agenda?"* To the surprise of many attending the Board meetings, the Board would say that we don't have an agenda.

It is true, even today we don't have a detailed agenda. But we are quickly developing one with your input and lots of open discussion. The Board is developing a 2009-2013 IMRPD Strategic Plan. We are going through a deliberate process of asking property owners how and where they would like their tax dollars spent. In addition to the open Board study sessions and regular meetings this summer, we quickly developed and mailed the 2008 Indian Mountain Recreation Survey to all 2050 IM property owners. Over 250 responses have been received as of September 1st.

The tables included in this newsletter (pages 4-5) share with you what we learned from the survey. This information will be useful in setting priorities, making decisions, and allocating resources. In the next few months we will set priorities, do some additional costing out of big ticket items, and develop a sequence of what actions should come first, second, and third. We will continue to seek your input during this process and pledge to you that our decisions will be well reasoned and transparent.



State Trust Land Abuse

The 640 acres of State Trust land south of Longbow Drive, east of Ouray Trail, west of Forest Service Roads # 830 and 833, and north of The Buffalo is NOT public land. This land was awarded a 10 year grazing lease to a local rancher in March 2008, and has never been designated land for public use.

There are no trespassing signs posted, but ATVs have been spotted numerous times driving through the meadows. IMPOA wants to encourage our property owners to please respect the rancher's privacy and to not trespass on this land.

IMPOA and IMRPD are researching a compatible recreation use lease with the State Land Board on this land for the future, but until an agreement can be reached, it will benefit us all if we respect this private property.


It is good to remember that we have easy public access to hundreds of thousands of acres of public lands adjacent to our IM subdivision borders. Access for the National Forest land is off of Longbow Drive 1 mile east of the Indian Mountain Comfort Station, as well as off Remington Road in the Buffalo subdivision.

Helpful Reminders from Rocky Mountain ATV Club

Where to Ride

There are hundreds and hundreds of miles of old mining and logging roads in the Rocky Mountains for you to enjoy. Basically you can ride on any dirt road that meets the following conditions:

- It is on BLM or National Forest land
- It is NOT a County Road (such as all the dirt streets that traverse Indian Mountain, Stagestop, Elkhorn, etc.)
- It is NOT marked "Closed to Motorized Vehicles".
- It is NOT in a wilderness area.
- Stay on the trails. You must stay on existing trails and roads. Riding cross-country is the fastest way for all of us to lose our riding privileges. There is a lot of pressure on the government agencies to restrict and or close access to ATV's and dirt bikes, so respect the environment and follow the rules or the next time you come for a visit there may be no place to ride.

There have been numerous reports of ATVs not following these rules in Indian Mountain. The Park County Sheriff's office has recommended that as a citizen you can report misuse of ATVs by calling Park County Dispatch at 1-719-836-4122 (#5).




RV Reminder

Please remove your RV from your lot by November 1. Indian Mountain Recreation and Park District has storage for RVs located near the Recrea-

tion Hall, not far from the Fire House, for your convenience. Indian Mountain Subdivision covenants state: "...owner may camp on his property, using a tent, camper or temporary trailer for a period not to exceed 90 days or 30 consecutive days in any calendar year." This covenant makes no distinction regarding RVs on developed or undeveloped lots.





Plans are in the making for better cellular phone service to the Indian Mountain area. Amanda Woodbury Gardner, wife of the former county commissioner Jim Gardner, is currently negotiating with Commet Wireless to put a tower on her 10K hilltop.

The location of the tower would be at the center of the SW quarter of section 33, T9S and R75W. This hill top location is well inside Gardner ranch located west of Falcon Rd. which takes off west of Pinto Trail in Elkhorn Ranches area.

The tower is called a Lite Site or monopole and is about 65 feet tall.

The cell tower location still needs to go through the county planning and approval process. If you have an opinion on this matter you might email or call the Planning Commission or your County Commissioner.
