Hello,

I was appointed to the Indian Mountain Metropolitan District Board in September of 2020. Since that time, I have served as Vice President II and Vice President I. At the August board meeting, the board voted for me to assume the duties of President and for Glenn Haas who had been the interim President to assume the duties of Vice President I. Thank you, Glenn, for all you do.

I am retired and have lived in Indian Mountain full time since January of 2014. I moved here after retiring from Western Union Corporation. For the last 2 years with the company I was Vice President of Global Sourcing. Prior to that, I was a Vice President in the Information Technology organization where I managed a variety of organizations including data centers, software development and quality assurance. The board is currently working on our 5-year budget plan to address both immediate improvements needed at some facilities as well as making sure we have a plan for maintaining all of our facilities as our community grows.

For example, IMMD placed a lid and lock on the dump station to ensure that the usage of this amenity was limited to IMMD residents. Keys are available to residents at the community center. However, it has already been broken into and damaged twice this summer. There have also been increased reports of trespassing onto private property. We can all help our community and one another by keeping our eyes open for things that seem out of the ordinary and looking out for our neighbors.

Firewise Community

Indian Mountain will continue its status as a Firewise Community for 2022. The burn pit had over 1,000 loads brought in which equates to over 3500 hours that owners spent mitigating their property. There were also over 300 hours that volunteers spent staffing the burn pit. Both of these combined to bring over \$100,000 of value to our community. The burn pit was open much later than last year which allowed owners to work their property that much longer. It was opened up to owners in other subdivisions for a small fee and 1 mandatory volunteer session. Please consider volunteering at the burn pit – it's a great way to meet your neighbors and have fun, it's really pretty easy! Over 40 properties had slash piles either picked up or removed, 1 property had 70 slash piles! We will continue this work next year and hope that as we progress over time, there will be less and less to mitigate.
